

Internet Access Resources for Families

Internet access is an essential part of being able to connect with teachers and classmates. If you do not already have service, we have multiple options below to provide you with free or reduced cost internet.

Twin Rivers is providing free internet access to many district families in a partnership with Comcast This program is available to most Twin Rivers students, with some basic limitations on availability; this is the fastest available completely free service at this time. See the steps below to apply:

- 1. Confirm your household has Comcast available qualifies for service via our partner page, here: https://www.internetessentials.com/apply
- 2. If you qualify, a special Twin Rivers provided code will allow the District to pay for the monthly cost. All costs will be covered by Twin Rivers, there will be no monthly cost to you.
 - Confirm you qualify at the link above, then Twin Rivers Technology Support at techsupport@twinriversusd.org or (916) 566-7802 to obtain the free Comcast sign-up code.
- 3. Complete the application and signup process at the link specified in Step 1 above.

If for any reason you do not qualify or cannot obtain the Comcast service option above, we have identified these alternative services offering low or no cost internet that may help:

High speed personal internet services are available at low cost from several other location providers. See the reverse side of this page for a list of providers and the low-cost options these

If these other options are not available to you for any reason, Twin Rivers has wifi hotspots available for free check-out, one per Twin Rivers student household. These hotspots allow up to 15 students per family to have basic internet access, with speed sufficient for basic schoolwork.

AT&T Low Cost Internet Access

AT&T is offering internet service for \$10/mo or less, with wifi access, no contract, no deposit, and free installation for qualifying families. Eligibility includes households that participate in the Supplemental Nutrition Assistance Program, National School Lunch Program, Head Start, or those receiving Supplemental Security Income benefits in California.
